- 1. The selected candidates must get themselves admitted into MBA programme (I), 2017-19 from 11th May, 2017 onwards. Candidates yet to clear their graduation would be admitted provisionally. However, such candidates must submit proof of having clearing the exam prior to commencement of 1st semester MBA examination by December, 2017. Last date for taking admission into MBA programme (I), 2017-19 is 23rd May, 2017.
- 2. Selected candidates must produce two nos. of passport sized photographs along with one copy of each of the following documents

I. Proof of age

- II. HSLC(Class 10)marksheet and pass certificate
- III. HSSLC(10+2)marksheet and pass certificate
- IV. Graduation marksheet and pass certificate
- V. Category certificate(if belonging to any reserved category)

VI. Proof of address

VII. Migration certificate (wherever applicable)

VIII. Anti-ragging form (to be downloaded from University website). Students who have not produced the original certificates on the day of interview must have to produce the same on the day of admission, failing which they would not be admitted.

3. Fee details

- I. Candidates willing to get admitted must pay the Programme fee for First semester i.e. Rs.47, 250/- (Forty Seven Thousand Two Hundred and Fifty only) at the time of admission. However, students may also pay the entire Programme fee of Rs.1, 50,000/- (One Lakh Fifty Thousand only) during admission.
- II. The Admission fee must be paid in the form of a **Demand Draft in favour of Assam Rajiv Gandhi University of Cooperative Management, Sivasagar** and drawn on any nationalised bank of India.
- 4. Candidates willing to stay in the **University hostel contact the Admission Coordinator** at the time of admission. Hostel seat will be allotted on first come first serve basis.
