The selected candidates are to note the following:


1. **The selected candidates must get themselves admitted** into MBA programme (I), 2018-20 from **6th July, 2018 onwards**. Candidates yet to clear their graduation would be admitted provisionally. However, prior to commencement of 1st semester MBA examination by December, 2018, such candidates must submit proof of having clearing the exam with minimum qualifying marks i.e. 50% for general category and 45% for reserved category in graduation. Last date for taking admission into MBA programme (I), **2018-20 is 11th July, 2018**.
2. **Selected candidates must produce** two nos. of passport sized photographs along with one copy of each of the following documents:
 - I. Graduation marksheet and pass certificate(semester marks for the appearing candidates)
 - II. Category certificate (if belonging to any reserved category)
 - III. Proof of address
 - IV. Anti-ragging form (to be downloaded from University website).


Students who have not produced the original certificates on the day of interview must have to produce the same on the day of admission, failing which they would not be admitted.

3. Fee details

- I. Candidates willing to get admitted must pay the **Programme fee for First semester i.e. Rs.47, 250/- (Forty Seven Thousand Two Hundred and Fifty only) at the time of admission.**
 - II. **The Admission fee must be paid in the form of a Demand Draft in favour of Assam Rajiv Gandhi University of Cooperative Management, Sivasagar and drawn on any nationalized bank of India.**
4. Candidates willing to stay in the University hostel may contact the Admission Coordinator at the time of admission. Hostel seat will be allotted on first come first serve basis.
